Shipping Conditions:

Rates apply only on shipments loaded in railroad owned or leased covered hopper cars, unless otherwise agreed by CPRS and TCWR. Rates are not subject to diversion, inspection, re-consignment, or transit privileges. Railroads will not absorb any switch charges. CAR ORDER MUST BE PLACED A MINIMUM OF SEVEN (7) DAYS PRIOR TO REQUESTED PLACEMENT PERIOD. Rates are in U.S. Funds. **The maximum gross weight on cars loaded on TCWR is 286,000 lbs., or the maximum weight marked on each rail car, whichever is less.** Rates are subject to TCWR Fuel Surcharge Tariff series-9020. Above rate is a unit train rate and is subject to Canadian Pacific Railway supplying locomotive power to TCWR for such shipments under locomotive use arrangements and other arrangements at no charge. Rail cars to be provided by Canadian Pacific Railway unless otherwise agreed by CPRS and TCWR.

ROUTE 1: TCWR-STPAU-CPRS-CHGO

Low Cap: Applies in cars with a capacity not exceeding 4,800 cubic feet capacity.

High Cap: Applies in cars with a capacity exceeding 4,800 cubic feet capacity.

Price must be used in combination with other prices for the portion of the shipment subsequent to the above destination (Rule 11). Rates apply only for 100 cars moving to one destination able to receive 100 rail cars in a single switch.
