Rail car(s) held on storage tracks with TCWR's approval will not be subject to demurrage in accordance with the terms of TCWR Tariff 8400-Series. Prior authorization from TCWR's Marketing & Sales Department pursuant to terms and conditions provided by TCWR must be provided by TCWR before storage of rail car(s) will be permitted, otherwise rail cars will be subject to demurrage in accordance with the terms of Tariff TCWR 8400-Series.
