Shipping Conditions:

Rates apply only on shipments loaded in railroad owned or controlled covered hopper cars, unless otherwise agreed by CPRS and TCWR. Rates are not subject to diversion, inspection, re-consignment, or transit privileges. Railroads will not absorb any switch charges. CAR ORDER MUST BE PLACED A MINIMUM OF SEVEN (7) DAYS PRIOR TO REQUESTED PLACEMENT PERIOD. Rates are in U.S. Funds. **The maximum gross weight on cars loaded on TCWR is 286,000 lbs., or the maximum weight marked on each rail car, whichever is less.** Rates are subject to CPRS 9700 mileage-based fuel surcharge. Above rates are unit train rates and are subject to Canadian Pacific Railway supplying locomotive power to TCWR for such shipments. Rail cars to be provided by Canadian Pacific Railway unless otherwise agreed by CPRS and TCWR. Private equipment is not subject to mileage allowance.

ROUTE 1: TCWR-STPAU-CPRS

Alberta, Canada destinations: Blackie, Carmangay, Carseland, Cassils, Grassy Lake, Indus, Lethbridge, Red Coat, Stirling, Transmark, Vulcan and Wilson.

Low Cap: Applies in cars having a marked capacity less than 4,999 cubic foot capacity

High Cap: Applies in cars having a marked capacity equal to or greater than 5,000 cubic foot capacity.

The above unit train rates apply only for 110 cars (or max siding capacity, minimum 100 cars) moving to one destination able to receive all 110 rail cars in a single switch.
