JOB DESCRIPTION

Summary/Objective

To maintain and repair track structure (roadbed, switches, rail, ties, etc.) in a safe and effective manner; to assist in other areas and with other duties as assigned.

Essential Functions

Individuals working must meet all the essential functions physical demands, deviations are not available for these positions due to the physical requirements of the position and the safety sensitivity of the position.

- 1. Repair and maintain track and structure deviations in accordance with Federal Railroad Administration (FRA) and Company specifications, as directed.
- 2. Familiarity and compliance with FRA and General Code rules and regulations.
- 3. Safely and efficiently operate equipment such as grinders, drills and other track equipment and/or power machinery.
- 4. Be vigilant of track and structures issues, observing conditions which may impact personal or company safety and/or property.
- 5. Constant awareness of personal safety, and notification of supervisor of any potential safety hazards for corrective action. Maintain compliance with TCW's On-Track Safety program.
- 6. Professionally and respectfully communicate both in verbal and written communications in English.
- 7. Focus on TEAMWORK, COMMITMENT & WILLINGNESS in the aid of other departments as necessary.

Supervisory Responsibility

This position has no supervisory responsibilities.

Work Environment

This position operates heavy equipment in the outdoor environments, subject to all weather seasons / elements. This role routinely uses heavy equipment.

Position Type/Expected Hours of Work

This is a full-time non-exempt position. Normal operating hours traditionally start at 0600 each day (Monday – Friday). On an as needed basis, due to emergency situations, weekend assistance may be needed.

Physical Demands

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

While performing the duties of this job, the employee is regularly required to use hands and fingers to handle, feel, or operate objects, tools or controls, and reach with hands and arms. The employee is frequently required to stand, talk and hear.

Travel

During TCW's traditional work season, travel will be required for week-long stay outs. Who travels and when is depended on where the track work is being performed. Additional travel may be required for trainings and seminars.

- 3. Possess a strong work ethic and high level of integrity.

Preferred Education and Experience

1. Prior railroad track experience and knowledge of the FRA Track Safety Rules, applicable Federal, State and Local laws throughout territory along with extensive knowledge of GCOR.

Additional Eligibility Qualifications

Employees working in a safety sensitive environment are subject to random pool drug testing. Maintenance of Way Technicians are employees who are required to drive a company vehicle for business on a regular basis and must meet our auto insurance requirements.
