FUEL SURCHARGE TARIFF

A mileage-based fuel surcharge will be applied to each qualifying shipment as outlined below:

 All local carload traffic originating on Minnesota Prairie Line, Inc. (MPLI) and billed via MPLI when freight rate tariffs make reference to this surcharge tariff.
All joint line carload traffic originating on MPLI and billed via MPLI when moving on through or proportional rates published by MPLI and reference is made to this surcharge tariff.
All carload traffic terminating on MPLI either moving on through rates or Rule 11 rates published by MPLI and billed freight collect. All applicable freight rate tariffs must make reference to this surcharge tariff.
The fuel surcharge will be billed on a per car basis to the payer of freight charges.

MPLI will apply a fuel surcharge, which will be adjusted on a monthly basis, to linehaul freight charges based on the U.S. Average price of Department of Energy On-Highway Diesel Fuel Price (OHD) for a calendar month, as reported weekly on the U.S. Department of Energy website(see: http://www.fwccinc.com/doefuel.html). When the monthly average price of OHD equals or exceeds \$2.30 in the second calendar month prior to the month in which the fuel surcharge is applied, the fuel surcharge rate per mile as shown in the following OHD Fuel Surcharge Table will be applied to the linehaul freight charge. For example, the surcharge amount in April will be calculated from the monthly average OHD price during February. Rail mileage is calculated using 3rd party software PC*Miler Rail product on each linehaul movement. If linehaul interline price routing is involved, mileages will be calculated via the revenue route junction(s) of the price used to rate the shipments. Where the rail miles are not available through PC*Miler, MPLI will calculate and publish the mileage independently.

For shipments which originate on MPLI and terminate in the Minneapolis/St. Paul terminal area or proceed through the Minneapolis/St. Paul terminal area on a Rule 11 basis, mileage used to calculate fuel surcharge shall be based on mileage to St. Paul, MN. For shipments which Terminate on MPLI and originate in the Minneapolis/St. Paul terminal area or move to MPLI through the Minneapolis/St. Paul terminal area on a Rule 11 basis, mileage used to calculate fuel surcharge shall be based on mileage from St. Paul, MN.

The date of surcharge shall be applied as follows:
