Rates are in U.S. Funds. **The maximum gross weight on cars loaded on TCWR is 286,000 lbs. or the maximum weight marked on each rail car, whichever is less.** Rates are subject to CPRS 9700 mileage-based fuel surcharge. Above rates are unit train rates and are subject to Canadian Pacific Railway supplying locomotive power to TCWR for such shipments under locomotive use arrangements at no charge. **Rates apply on export traffic only.** Shipments moving hereunder shall be billed on a prepaid basis. TCWR will issue all freight bills.
