Shipping Conditions:

Rates apply only on shipments loaded in railroad owned or leased covered hopper cars. **Rates** are not subject to diversion, inspection, re-consignment, or transit privileges. Rates are also subject to demurrage provisions in Tariff TCWR 8400-Series. **Rates apply for single cars (1 to 24) only.** Rates are in U.S. Dollars. **The maximum gross weight on cars loaded on the TC&W is 268,000 lbs. and 263,000 lbs. on the SMRR.**

Intermediate rate application - origin points: The rate for service provided to a published destination point from an origin point not specifically named in this tariff, but located intermediate to published origin, is the same as the published rate from the next more distant origin point.
