- **Rates cannot be used as proportional rates in connection with UP line haul rates.**
- Subject to the provisions in TCWR Tariffs 8400 and 8500 Series
- Rates are not subject to diversion, inspection, re-consignment, transit or weighing privileges and freight bills cannot be recorded for transit at destination.
- Equipment can be Railroad or private marked cars, zero mileage payments.
- Rates are applicable in cars not exceeding maximum gross weight limit of 268,000 on TCWR lbs. on TCWR origins except when Group 3 origins maximum is 263,000 lbs.
- Origin and destination information provided by customer for car orders for which a permit has been issued by TCWR cannot be changed without the permission of TCWR.
